RESOLUTION APPROVING AMENDMENTS TO THE  
SCHEDULE OF FEES FOR TRANSIENT MERCHANTS

WHEREAS, Section 78-69 of the City Code provides that an applicant for a transient merchant license shall pay a fee at the time of filing the application in the amount set in the schedule of fees adopted by the City Council by resolution; and,

WHEREAS, a proposed ordinance is now under consideration by the City Council which would amend the regulations applicable to transient merchants and provide for the issuance of three day, thirty day and annual transient merchant licenses; and,

WHEREAS, the City Manager recommends that the application and administrative fees for transient merchant licenses be amended as set forth in the accompanying schedule; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the adopted schedule of fees for the City of Des Moines is hereby amended by amendment of the fees imposed pursuant to Section 78-69 of the City Code regarding transient merchants, to be as set forth in the accompanying schedule.
