ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance 14,425 passed March 28, 2005, and by Ordinance 14,663 passed June 18, 2007, and by Ordinance 14,737 passed January 7, 2008, and by Ordinance 14,771 passed June 9, 2008, by amending Section 74-184 thereof, relating to Brenton Skating Plaza fees.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance 14,425 passed March 28, 2005, and by Ordinance 14,663 passed June 18, 2007, and by Ordinance 14,737 passed January 7, 2008, and by Ordinance 14,771 passed June 9, 2008, is hereby amended by amending Section 74-184 thereof, relating to Brenton Skating Plaza fees, as follows:

**Sec. 74-184. Brenton Skating Plaza fees.**

(a) Fees for use of the Brenton Skating Plaza ice rink shall be as follows:

- (1) Ice rink admissions:
  - a. Adult (13 years and older): \$ 3.00 Monday-Friday 7:00 p.m.  
Adult (13 years and older): \$ 4.50 Weekends and holidays
  - b. Child/Senior (62 years and older) \$ 2.00 Monday-Friday 7:00 p.m.  
Child/Senior (62 years and older) \$ 3.50 Weekends and holidays
  - c. Freestyle (figure skating only): \$ 7.00
  - d. Family night (Thursdays): \$ 8.50 (for family of four or more)
  - e. Season Pass – Adult \$ 95.00
  - f. Season Pass – Child \$ 60.00
  - g. Season Pass – Family \$ 95.00 for the first two family members and \$35.00 for each additional member with a maximum fee of \$199.00
- (2) Skate rental: \$ 2.50
- (3) Ice rink rental:
  - a. Private rental: \$250.00/hour
  - b. Private skate rental: \$ 2.50

- c. Private rental (non-profit): \$200.00/hour
  - d. Private (non-profit) skate rental: \$ 1.00
- (b) Fees for use of the Brenton Skating Plaza during the non-skating season are as follows:

	<u>Half Day</u> (up to 6 hours)	<u>Extra Charges</u>
Free Public Event	400.00	\$100.00 each additional hour
Fee-based event	\$750.00	\$100.00 each additional hour
Private social events (individuals)	\$350.00	\$100.00 each additional hour
Non-profit organizations (all uses)	\$350.00	\$100.00 each additional hour

- (c) Bike Rental Fees. Fees for use of bicycles and related equipment are as follows:

**Hybrids and Mountain Bikes (with helmet)\***

\$12.00 per hour  
 \$20.00 per ½ day (5 hours)  
 \$30.00 full day (24 hours)  
 \$80.00 per week (7 days)  
 \*\$5.00 off youth 12 and under  
 \*15% off groups of 15 or more

**Road Bikes (with helmet)\***

\$15.00 per hour  
 \$30.00 per ½ day (5 hours)  
 \$40.00 full day (24 hours)  
 \$110.00 per week (7 days)  
 \*\$5.00 off youth 12 and under  
 \*15% off groups of 15 or more

**Equipment**

Trailer bikes and carriers:  
 \$6.00 per hour  
 \$20.00 ½ day (5 hours)  
 \$30.00 full day (24 hours)
