## APPROVAL OF CONTRACT AND BOND AND PERMISSION TO SUBLET ON 2008 ENHANCED SCHOOL CROSSINGS AT SIGNALIZED INTERSECTIONS (SRTS) \$ 139,696.45

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$139,696.45, executed by Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 dated October 13, 2008, for the construction of the following improvement:

2008 Enhanced School Crossings at Signalized Intersections (SRTS), 04-2008-004 SRTS-U-1945(733)--8U-77

The improvements consist of upgrading existing traffic signals and pavement markings at various locations. All upgrades in accordance with the contract documents including Plan File Nos. 489-105/108, at the following locations in the City of Des Moines, Iowa:
