September 24, 2007  
City v. Tony Lemmo

HEARING OFFICER LEANN DUCEY: Good morning. My name is LeAnn Ducey and I'm an Administrative Hearing Officer. It is 8:55 a.m. on September 24, 2007 and we are conducting an administrative hearing on a vehicle impound. The appellant is Tony Lemmo. When I call you, Lemmo, is that correct? When I call you to give testimony today, please come to the podium, speak into the microphone and state your full name and address for the record. You will then be sworn in. This is an informal hearing and to that matter the hearing is now open. Would the representative from the City please come forward, identify yourself and provide any information you have pertaining to this hearing.

SENIOR OFFICER JEFF GOWEN: Senior Officer Jeff Gowen. Address will be 25 East 1<sup>st</sup> Street, City of Des Moines.

HEARING OFFICER LEANN DUCEY: Please raise your right hand. Do you Senior Officer Jeff Gowen, swear or affirm the testimony you are about to give is the truth, the whole truth and nothing but the truth?

SENIOR OFFICER JEFF GOWEN: I do.

HEARING OFFICER LEANN DUCEY: Go ahead please.

SENIOR OFFICER JEFF GOWEN: Uh, I was, uh, on routine patrol in the area of Grandview College. Uhm, a vehicle was observed in a no, posted no parking zone in the 900 block of Grandview, uh, Avenue at approximately, uh, the 29<sup>th</sup> of August a little after 10:00 o'clock, ten after 10:00 to be exact. Uhm, it was a silver 2000 Kia Sephia, 4-door and it was issued a citation and impounded, uh, reference the same charge.

HEARING OFFICER LEANN DUCEY: Okay.

SENIOR OFFICER JEFF GOWEN: Uh, when the complaint came down I saw that the, some pictures had been taken, uh, showing that the, I guess it being claimed that the sign was obstructed. Uh, I went out with the traffic unit yesterday and four photos were taken of the area as well as the sign.

HEARING OFFICER LEANN DUCEY: Okay. Okay. Could I please see that? Thank you.

SENIOR OFFICER JEFF GOWEN: Yep.

HEARING OFFICER LEANN DUCEY: I'll enter these as City Exhibit "A". Okay. Anything else?

SENIOR OFFICER JEFF GOWEN: No.

HEARING OFFICER LEANN DUCEY: Okay. Mr. Lemmo please. Please state your name and address sir.

TONY LEMMO: Tony Lemmo. 1220 S.W. Creston Avenue here in Des Moines.

HEARING OFFICER LEANN DUCEY: Okay. Please raise your right hand. Do you Tony Lemmo, swear or affirm the testimony you are about to give is the truth, the whole truth and nothing but the truth?

TONY LEMMO: I do.

HEARING OFFICER LEANN DUCEY: Go ahead.

TONY LEMMO: Basically everything just self explanatory there in my, the written complaint and the pictures that I took so I just, uh, basically just here to contest why the vehicle was impounded and towed. It's a little difficult for most of those college kids to find a spot over there with all the construction going on and, uh, if you just read my, uh, reason for appeal that would a, hopefully explain to you why I'm here today.

HEARING OFFICER LEANN DUCEY: Uh huh.

TONY LEMMO: And you also should have two pictures that I brought down on the date.

HEARING OFFICER LEANN DUCEY: Uhm, I can see how, what you're saying, uh, in your request for a hearing. You said my daughter was parked in this area because she is attending Grandview College. The sign "no parking here to corner" is partially covered by tree branches and as she exited the car to get books from trunk she did not see this sign and then see attached pictures. Uhm, the, the sign is partially covered. Uh, it depends on where you're looking at it, but you can definitely see the sign pole and you should be, you know, I mean you can see the pole, you might need to, to look a little harder to see what the sign says but I'm pretty familiar with that area. I think that there's a lot of these signs posted all around Grandview, likewise at Drake and, and all these places. Uhm, I don't know if maybe your daughter was kind of in a hurry to get to class or whatever.

TONY LEMMO: Well it's not in a hurry, just that it's very difficult to find a parking spot there with the construction going on on Grandview Avenue.

HEARING OFFICER LEANN DUCEY: Right.

TONY LEMMO: The parking lots....

HEARING OFFICER LEANN DUCEY: But she did park illegally.

TONY LEMMO: That is correct, but she did not see the sign.

HEARING OFFICER LEANN DUCEY: Okay.

TONY LEMMO: And I, that's what she's told me and that's, I believe her.

HEARING OFFICER LEANN DUCEY: Well, I'm not saying that, I'm not saying that she's a liar. I'm saying that, ya know, that part of it at least is visible and maybe if she'd tried a little bit harder she could have seen it.

TONY LEMMO: Well, if you're looking, I'm not sure which pictures you're looking at, whether the Officer's or my pictures, but...

HEARING OFFICER LEANN DUCEY: I'm looking at your pictures right here.

TONY LEMMO: Okay. Uhm.....

HEARING OFFICER LEANN DUCEY: I can see a, I see a pole.

TONY LEMMO: Correct, but that's, that was a pictures taken a couple days later obviously and there was also, there was a car there next to that pole. My daughter was actually farther back than that. So, yeah, if you're, if you see the silver SUV that parked there in the picture, there was also another car behind that and she was even farther back closer to, I think it's probably 9<sup>th</sup> Street. I'm not that familiar with that area, but I think that's 9<sup>th</sup> that runs north/south. So if she was heading north and turning on this street here she, uh, she would have been about even with the tree and, and there's no way that she said she seen that sign.

HEARING OFFICER LEANN DUCEY: Okay.

TONY LEMMO: I wouldn't mind paying the fee, but I think having it towed was a little bit out of line.

HEARING OFFICER LEANN DUCEY: Sir, they have to or else everybody else starts parking there too. I mean it, it, it's a law and unfortunately there is not much parking in that area and, uhm, I don't know what to tell you except maybe if she could try to get there a little bit earlier she'd be able to find parking. I don't know. I don't know what the situation is. All I know is that it is posted and it is clear so I am ruling in favor of the City. Should you disagree you have the right to file an appeal with the City Council and in the ruling that I will be send you it states how to do that. Thank you very much.

Dear Mr. ~~Or~~<sup>Lemmo</sup>:

In response to your written appeal, the City of Des Moines convened an Administrative Hearing on September 24, 2007 at 8:45 a.m. regarding a motor vehicle impound (Impound Tag Number 270307). Pursuant to Section 114-485.16 of the Municipal Code, you were given an opportunity to be heard at that time.

The issue before the Hearing Officer was the removal and impoundment of an illegally parked vehicle. Section 114-485.11 of the Municipal Code states, "...[that] the police department...may remove and impound vehicles or cause vehicles to be removed and impounded when the vehicles are stopped or parked in violation of this chapter or other city ordinances and, in so doing, may employ such means as are reasonably necessary.

Sr. Officer Gowen said he was on regular patrol when he saw a vehicle parked in a posted "No Parking" zone at approximately 10:10 a.m. Sr. Officer Gowen said he issued a citation and had the vehicle impounded. Sr. Officer Gowen presented City Exhibit A into evidence.

Tony Lemmo, titleholder of the vehicle, said his daughter was driving his car and attending Grandview College. Mr. Lemmo said there was a tree branch partially covering the "No Parking Here To Corner" sign and she told him she exited the car, got her books from out of the trunk and did not see the sign. Mr. Lemmo attached two pictures with his Request for Administrative Hearing." (Appellant Exhibit 1)

I find probable cause was proven for the impound. You have the right to appeal the ruling to the City Council by filing an appeal with the City Clerk's Office within seven (7) days of receipt of the ruling. Your appeal must include the reason upon which you are basing your appeal. You are also responsible for payment of ticket #7033480.



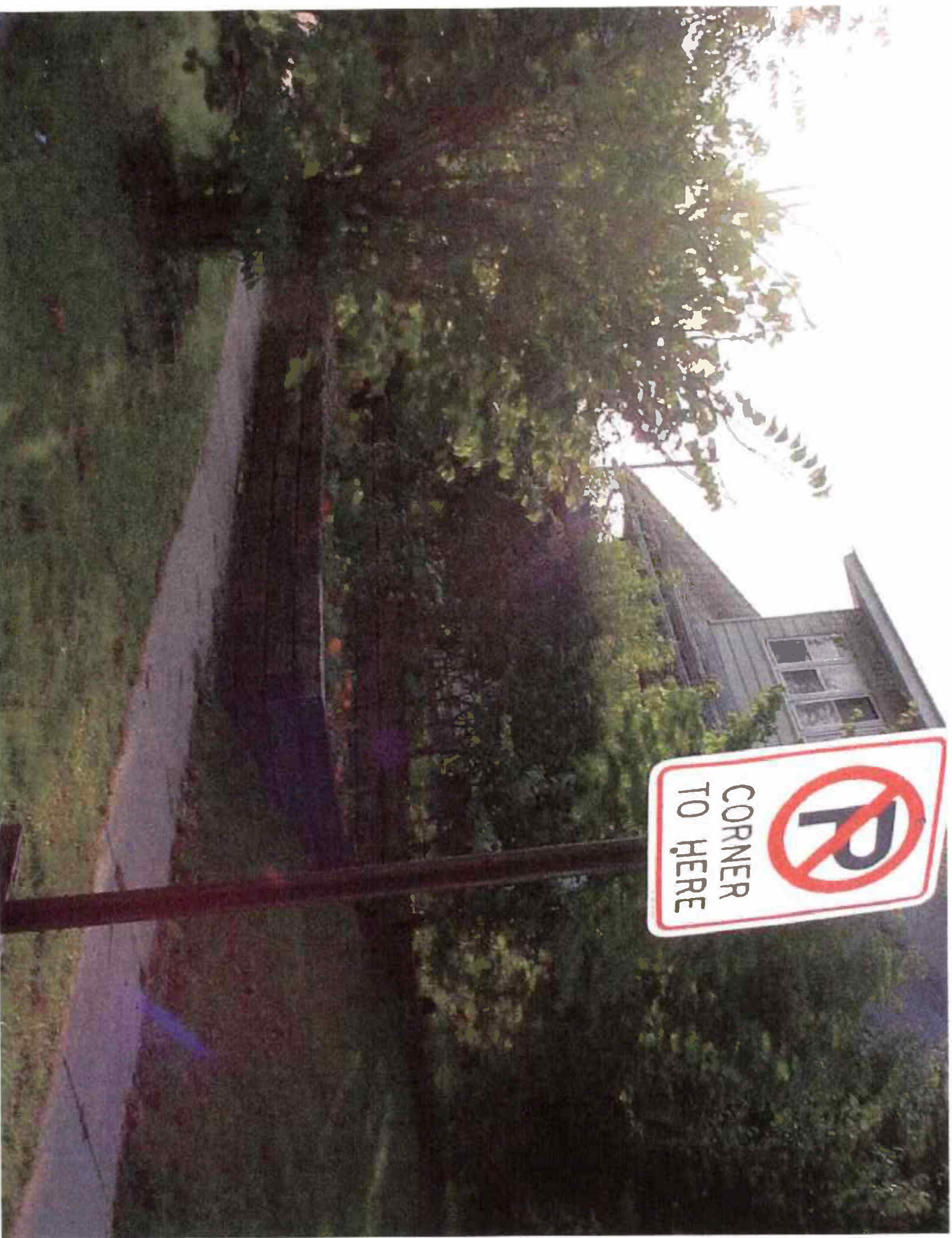
