RESOLUTION APPROVING VOLUNTARY ANNEXATION OF TERRITORY IN UNINCORPORATED POLK COUNTY (Darlene A. Fini)

WHEREAS, the City of Des Moines has received the accompanying Application for Voluntary Annexation from Darlene A. Fini, seeking the voluntary annexation by the City of Des Moines of approximately 63 acres of land she owns between NE 38th Avenue (E. Douglas Avenue) and NE 30th Place and west of NE 56th Street, generally shown on Exhibit "A" and more specifically described in the accompanying Exhibit "B"; and,

WHEREAS, to avoid the illegal creation islands of unincorporated land surrounded by the City of Des Moines, it is further proposed that the following additional tracts of land generally shown on Exhibit "A-1" and more specifically described in the accompanying Exhibit "B" be included in the Territory to be annexed without the owners' consent:

5371 NE 38th Ave, owned by: Carmen Terwilliger

5383 NE 38th Ave, owned by: Edwin D. Briggs and Marcy C. Briggs

5411 NE 38th Ave, owned by: Connie S. Waugh

5501 NE 38th Ave, owned by: Stephen L. Fini

5523 NE 38th Ave, owned by: Joel S. Fini and Kelli J. Kelderman

5545 NE 38th Ave, owned by: Tony E. Newton and Angie L. Newton

WHEREAS, it is further proposed that the Territory include the adjoining 1/2 of all intervening and adjoining secondary roads, as generally shown on Exhibit "A-1" and more specifically described in the accompanying Exhibit "B"; and,

WHEREAS, on August 21, 2007, by Roll Call No. 07-1601, the City Council resolved that the proposed annexation be set down for consideration by the City Council at a public hearing to be held in the Council Chambers on October 22, 2007, at 5:00 p.m.; and,

WHEREAS, notice of the proposed annexation was given to the Polk County Board of Supervisors and to the Delaware Township Board of Trustees by letter of August 15, 2007, and they were invited to a consultation meeting with City staff held at 1:10 p.m., on August 27, 2007, in the Kofu Conference Room at City Hall, to discuss the proposed annexation; and,

WHEREAS, neither the county nor township sent representatives to the consultation meeting; and,

WHEREAS, due notice of the public hearing was sent by certified or regular mail on September 18, 2007, to all affected utilities, to all other cities located within two miles of the Property, to the Polk County Board of Supervisors and County Attorney, and to all applicants and owners of land included in and adjoining the territory proposed to be annexed as required by Sections 368.5 and 368.7 of the Iowa Code; and,

WHEREAS, a second notice was sent on September 24, 2007, by certified mail, return receipt requested, to all owners of land within the territory proposed to be annexed who have not previously consented to the annexation; and,

WHEREAS, due notice of the public hearing was published in the Des Moines Register on September 18, 2007, as provided by law, setting forth the time and place for hearing on said proposed annexation; and,

WHEREAS, in accordance with the published and mailed notice, those interested in the annexation, both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council; and,

WHEREAS, the territory proposed to be annexed adjoins the boundaries of the City of Des Moines; is not within the boundaries of any city; and, is located within two miles of the boundaries of the cities of Pleasant Hill and Altoona; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts, statements of interested persons and arguments of counsel, the objections to the proposed annexation are hereby overruled and the hearing is closed.
- 2. The annexation of the territory generally shown on the map attached hereto as Exhibit "A-1" and more specifically described Exhibit "B" is hereby found to be consistent with the City's long range plans for the area, and is hereby approved.
- 3. If the applicants do not withdraw her application within five business days of this date, the City Clerk is hereby authorized and directed to then forward a certified copy of this resolution and accompanying exhibits, to the Legal Department for filing with the City Development Board.
