APPROVING PARTIAL RELEASE OF LIEN IN CONJUNCTION WITH THE EASTER LAKE SANITARY TRUNK SEWER CONNECTION FEE AGREEMENT AND COVENANT, AND DIRECT THE LEGAL DEPARTMENT TO BRING BACK AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE RELEASE OF LIENS ASSOCIATED WITH ANY SEWER CONNECTION FEE AGREEMENT AND COVENANT

WHEREAS, on October 6, 2003, by Resolution No. 03-2317, the City Council approved a Sewer Connection Fee Agreement and Covenant with Gerald D. Grubb (the developer) for residential development of the property; and

WHEREAS, the developer was proposing to develop only 35 buildable lots at that time, leaving a portion of the property undeveloped until there was a market for further development; and

WHEREAS, pursuant to that agreement, the City agreed to defer payment of the connection fee for the property that was not being developed at that time in exchange for the commitments with respect to the payment of the sewer connection fees on the undeveloped property; and

WHEREAS, by virtue of the Agreement, the Developer gave the City, a first lien against the undeveloped property as security for payment of deferred amounts; and

WHEREAS, the City has received payment for sewer connection fee on the following property legally described as follows:

Lots 1 thru 70 of Carman Estates Plat 2, an Official Plat all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Lots 1 thru 12 of Carman Estates Plat 3, an Official Plat all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Lots 1 thru 42 of Carman Estates Plat 4, an Official Plat all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Lots 1 thru 6 of Carman Estates Plat 5, an Official Plat all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

- 3. That the Legal Department is directed to bring back an ordinance authorizing the City Manager or an authorized Representative to execute Releases of Liens associated with payments provided for in any Sewer Connection Fee Agreement and Covenant.
