WHEREAS, the Procurement Administrator and the Fire Department recommend approval of the low dollar compliant bid for nitrile gloves;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to FirstLine Gloves, and further authorizes the Procurement Administrator to enter into an annual agreement renewable for two (2) additional twelve (12) month periods.
