RESOLUTION APPROVING SUPPORT FOR AN APPLICATION TO THE IOWA HOUSING FINANCE AUTHORITY SUBMITTED BY WILLOW BEND I, L.P. REQUESTING LOW INCOME HOUSING TAX CREDITS FOR REHABILITATION OF 60 UNITS HOUSING LOCATED AT 6616, 6700 AND 6800 SW 9TH STREET

WHEREAS, the City of Des Moines, Iowa, has been informed by James C. Conlin, President, Conlin Properties 319 7th Street, Suite 500 Des Moines, Managing Partner of Willow Bend I L.P., that a Low Income Housing Tax Credit (LIHTC) application will be filed with the Iowa Finance Authority for the rehabilitation of 60 units of housing located at 6616, 6700 and 6800 SW 9th Street property more specifically described as follows:

W 100 F E 133 F S 136 F N977F NW ¹/₄ Sec 33-78-24; and LOTS 24, 25, & 26 BLK 6 RODGERS PLACE, W 100F E 133F S 272F N 1289F NW ¹/₄ Sec 33-78-24; and lots 21 thru 26 BLK 7 ROGERS PLACE, W 100F E 133F S 272F N 1601 NW ¹/₄ SEC 33-78-24; AND LOTS 21 THRU 26 BLK 10 RODGERS PLACE

WHEREAS, the developer has not requested local assistance beyond tax abatement;

WHEREAS, this project involves rehabilitation of existing family housing; and

WHEREAS, the City's Affordable Housing project is not applicable because the project is rehabilitation of existing assisted units; and

WHEREAS, rehabilitation of this project will enhance the SW 9th Street corridor across from the zoo and will ensure housing is provided to low income families; and

WHEREAS, Conlin Development is an experienced tax credit developer who has building, renovated, and managed many successful tax credit properties through the City.
