WHEREAS, an Evaluation and Selection Committee has reviewed the proposal and has recommended that a contract for such services be awarded to Technical Assistance Collaborative, Inc.; and

WHEREAS, the City Manager desires to negotiate a contract with Technical Assistance Collaborative, Inc., for the creation and implementation of an Action Plan to address homelessness in the amount of \$48,785.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa,

that:

1. The proposal for the creation and implementation of the Action Plan to address homelessness submitted by Technical Assistance Collaborative, Inc. is hereby accepted and approved.

The City Manager is hereby authorized to negotiate a contract with Technical Assistance 2. Collaborative, Inc. in the amount of \$48,785, subject to review and approval of the form of the contract by the Legal Department, and the City Manager is hereby authorized to execute such contract and to execute any additional documents that may be necessary under such a contract, and the City Clerk is hereby authorized to attest to the City Manager's signature.
