APPROVING DEVELOPMENT AGREEMENT AND AUTHORIZING EXECUTION OF CONTRACT DOCUMENTS FOR A \$350,000.00 GRANT TO JOE'S SQUARE L.L.C. FOR DEVELOPMENT OF A MIXED-USE PROJECT TO BE LOCATED AT BEAVER AVENUE AND FAGEN DRIVE

WHEREAS, on August 20, 2007 by Roll Call No. 07-1678, the City Council received and filed a communication from the City's Office of Economic Development (OED) regarding preliminary terms of agreement with Joe's Square L.L.C. ("Developer") for development of a mixed-use project at Beaver Avenue and Fagen Drive in the Beaverdale neighborhood of Des Moines and directed the City Manager to proceed with negotiations of a formal agreement; and

WHEREAS, on September 24, 2007 by Roll Call No. 07-1892, the City Council set November 19, 2007 as the date of public hearing to consider approval of the Beaverdale Commercial Area Urban Renewal Plan and the urban renewal area covered by such Plan includes the development project property; and

WHEREAS, OED staff and Joe's Square L.L.C. have negotiated the attached Development Agreement which eliminates the project's financing gap by providing an economic development grant consisting of \$350,000.00 in seven annual installments of \$50,000.00, with the initial payment to be made after the project has paid its first fully assessed property tax installment; and

WHEREAS, the development project furthers the stated goals and objectives in the draft Urban Renewal Plan and the development project complies with the general development controls and guidelines set forth in the Plan that are applicable to tax increment assisted projects; and

WHEREAS, on October 16, 2007, the Urban Design Review Board approved the Conceptual Development Plan and approved the proposed economic development grant assistance for the development project, and

WHEREAS, the grant may be funded out of the City's Economic Development Enterprise Account and, should the City Council approve the Beaverdale Commercial Area Urban Renewal Plan, any payments from such enterprise account will be treated as advances to the urban renewal project to be reimbursed with project tax increment revenues in seven annual installments of \$50,000.00 and such installments may be paid directly through project-generated tax increment; and

WHEREAS, a public purpose will reasonably be accomplished by the Economic Development Grant described herein because the public gains and benefits derived from the development project are warranted in comparison to the amount of funds dispensed.
