WHEREAS, on May 18, 2009 under Roll Call No. 09-826, the City Council approved a private construction contract in the amount of \$23,100.00, between Eco-Tech Construction, LLC, Steve Gillotti, President, 5600 Enterprise Drive, Grimes, IA, 50111 - as Contractor, and Nelson Development 15, L.L.C., Jake Christensen, Co-Manager, 1045 76th Street, Suite 2000, West Des Moines, IA, 50266 - as Owner, for construction of Paving Improvements described as pavement widening on E 4th Street from E Grand Avenue to Des Moines Street in accordance with the contract documents including Plan File Nos. 475-129/130 for the new 300 East Grand Apartments project located at 300 E Grand Avenue, Des Moines, Iowa, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


