RESOLUTION APPROVING THE PUBLICATION OF THE NOTICE TO THE PUBLIC OF FINDING OF NO SIGNIFICANT IMPACT ON THE ENVIRONMENT FOR FUNDS FROM THE IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT FROM THE CONSOLIDATED SECURITY, DISASTER ASSISTANCE, AND CONTINUING APPROPRIATIONS ACT OF 2009

WHEREAS, the Iowa Department of Economic Development (IDED) has received U.S. federal funds under the Consolidated Security, Disaster Assistance, and Continuing Appropriations Act of 2009 (P.L. 110-329); and

WHEREAS, the City of Des Moines has contracted for funding with IDED on Contract 08-DRMH-016 for \$37,927 and 08-DRMH -021 for \$124,463 for the primary purpose of providing funding for acquisition and/or demolition, housing repair/rehabilitation, homebuyer assistance, interim mortgage assistance, rental repair/rehabilitation (small projects), rental repair/rehabilitation (large projects), single family new construction, multi-family new construction, public facilities and services and economic development in the City of Des Moines; and

WHEREAS, it is a requirement of HUD to prepare an Environmental Review Record (ERR) before federal or nonfederal funds can be released for the use of program activities; and

WHEREAS, the Department of Community Development is the HUD designated Responsible Entity (RE) and is required to prepare and maintain the ERR for HUD Grants awarded to projects in the City of Des Moines, Iowa; and

WHEREAS, the Department of Community Development has the responsibility to prepare and maintain the ERR for HUD grants and has determined that the project is Categorically Excluded subject to Sec.58.5 of the federal environmental review procedures under 24CFR Part 58.35.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the City Clerk is authorized and directed to publish the attached "Concurrent Notice to Public of Finding of No Significant Impact on the Environment and Notice to Public of Intent to Request Release of Funds" (Exhibit A) in the <u>Des Moines Register</u> on November 10, 2009, in accordance with 24 CFR 58.42, 58.43, and 58.44, which notices are hereby approved.

BE IT FURTHER RESOLVED that the Mayor is designated as certifying officer for purposes of 24 CFR 58.71 and the Mayor is authorized to execute the "Request for Release of Funds and Certification" (Exhibit B), and the "Environmental Assessment Worksheet" (Exhibit C) which forms are hereby approved, and the City Clerk is directed to attest to his signature.
