APPROVAL OF COMPREHENSIVE STRATEGY ENVIRONMENTAL REVIEW RECORD, FINDING OF NO SIGNIFICANT IMPACT ON THE ENVIRONMENT AND PUBLISHING NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

WHEREAS, as a grantee of the United States Department of Housing and Urban Development (HUD) under Title I of the Housing and Community Development Act of 1974 as amended, and as a grantee and/or a recipient under the Emergency Shelter Grant, Section 108 Loan Guarantee, HOME, and Supportive Housing Programs, the City of Des Moines conducted an environmental review pursuant to Title 24, Code of Federal Regulations (24 CFR) Part 58; and

WHEREAS, the cumulative environmental effects of activities to be undertaken as part of the City's Citywide Comprehensive Strategy Area during the 2010 Program Year, which includes the Community Development Block Grant, Emergency Shelter Grant, Section 108 Loan Guarantee, HOME and Supportive Housing Programs, were reviewed and included in the 2010 Environment Review Record (ERR); and

WHEREAS, after review of the ERR, the City found that the Citywide Comprehensive Strategy Area Projects are anticipated to not have a significant impact upon the environment; and

WHEREAS, the City recommends that no additional environmental review be conducted and a request for the immediate release of funds for the projects included in the First Year Action Plan (2010) of the 2010-2014 HUD Consolidated Plan for Community Development Block Grant, Emergency Shelter Grant, Section 108 Loan Guarantee, HOME and Supportive Housing Programs be submitted to HUD.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City's Comprehensive Strategy Environmental Review Record for the City's Citywide Comprehensive Strategy Area Projects, on file with the City Clerk as Exhibit A and by this reference made a part hereof, is hereby approved, and the findings and recommendations of the City are hereby approved.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to publish the attached "Public Notice of No Significant Impact and Notice of Intent to Request Release of Funds" (Exhibit B) in the <u>Des Moines Register</u> on November 13, 2009, in accordance with 24 CFR 58.42, 58.43, and 58.44.
