RESOLUTION ESTABLISHING FAIR MARKET VALUE AND AUTHORIZING VOLUNTARY ACQUISITION OF PROPERTY LOCATED AT 4315 S.E. 14TH STREET FROM PHYLLIS AND HAROLD ROGERS FOR REDEVELOPMENT IN THE S.E. 14TH STREET AND ARMY POST ROAD AREA FOR \$210,000

WHEREAS, on July 28, 2008, by Roll Call No. 08-1372 the City Council authorized the City Manager to work in cooperation with Polk County and Neighborhood Development Corporation to research potential redevelopment of property located at 4315 S.E. 14th Street; and

WHEREAS, the above property has been appraised by an independent appraisal firm and based upon the appraisal, the suggested fair market value of the property is as follows:

Suggested Fair Market Value: \$210,000


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:
