RESOLUTION INSTITUTING PROCEEDINGS TO TAKE ADDITIONAL ACTION FOR THE AUTHORIZATION OF A LOAN AGREEMENT AND THE ISSUANCE OF NOT TO EXCEED \$12,000,000 AVIATION SYSTEM REVENUE CAPITAL LOAN NOTES

WHEREAS, pursuant to notice published as required by law, this Council has held a public meeting and hearing upon the proposal to institute proceedings for the authorization and the issuance of not to exceed \$12,000,000 Aviation System Revenue Capital Loan Notes for the purpose of paying costs of construction of airfield and hanger improvements on the grounds of the Des Moines International Airport, 5800 Fleur Drive, Des Moines, Iowa, including those costs associated with the Mesaba Regional Jet Maintenance Facility Project, and the refunding and refinancing of the outstanding Subordinate Airport Commercial Paper Revenue Notes, Series C, the proceeds of which were used to acquire and construct runway, taxiway, terminal and cargo building improvements at the Des Moines International Airport, and has considered the extent of objections received from residents or property owners as to said proposal and, accordingly the following action is now considered to be in the best interests of the City and residents thereof:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That this Council does hereby institute proceedings and takes additional action for the authorization and issuance in the manner required by law of not to exceed \$12,000,000 Aviation System Revenue Capital Loan Notes for the foregoing purposes.
