WHEREAS, on October 27, 2008, by Roll Call No. 08-1845, it was duly resolved by the City Council that the application for Stratford Hold, LLC, to rezone certain property located in the vicinity of 1930 Indianola Avenue be set down for hearing on November 10, 2008, at 5:00 p.m. in the City Council Chambers at City Hall. The legal description is:

(Except Street) - Lots 8 thru 12. East of Line beginning 170.9 feet SW of SE corner Lot 8 thence Northwesterly 184.7 feet North line Lot 12 First Plat of Clifton Heights, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

WHEREAS, due notice of said hearing was published in the Des Register on October 30, 2008, as provided by law, setting forth the time and place for hearing on said proposed amendment to the Zoning Ordinance; and

WHEREAS, Iowa Code Section 415.4 requires that the property owner agree in writing to additional conditions to existing zoning regulations before the hearing on the limited rezoning. The Plan and Zoning Commission has recommended several such conditions; and

WHEREAS, the person authorized by the property owner to execute the Acceptance of Rezoning Ordinance containing the additional conditions is absent from the country and is unable to execute the Acceptance before the Council hearing on November 10, 2008. A representative from his office has requested that the initial hearing be postponed until the City Council meeting of November 24, 2008.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that upon due consideration of the facts, the initial hearing on the proposed rezoning at 1930 Indianola
