PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON E. 29TH STREET AND HUBBELL AVENUE TRAFFIC SIGNAL UPGRADE; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS BAKER ELECTRIC, INC., BRITT BAKER, CEO, \$107,018.00

WHEREAS, on October 22, 2007, under Roll Call No. 07-2009, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

E. 29th Street and Hubbell Avenue Traffic Signal Upgrade, 04-2007-002 CS-TSF-1945(715)--85-77

The improvement includes reconstructing the existing traffic signal to provide mast arm mounted signal indications and side-mounted signal indications on all approaches for better visibility in accordance with the contract documents including Plan File Nos. 478-089/094 at E. 29th Street and Hubbell Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.


