ACCEPTING TRANSFER OF OWNERSHIP AND CONTROL OF ELM GROVE CEMETERY FROM BLOOMFIELD BOARD OF TOWNSHIP TRUSTEES AND DEDICATION OF SAME AS CEMETERY

WHEREAS, the City of Des Moines owns numerous municipal cemeteries which are operated by the Park and Recreation Department; and

WHEREAS, effective on July 1, 1989, 7,169 acres of Bloomfield Township, including Elm Grove Cemetery, was annexed into the City of Des Moines: and

WHEREAS, on November 1, 2007, the Bloomfield Board of Township Trustees ('the Board") passed a resolution to transfer ownership and control of the Elm Grove Cemetery, located at 6505 Indianola Avenue, Des Moines, Iowa, and all remaining funds in the Elm Grove Cemetery operating account, after payment of all outstanding costs and expenses, to the City of Des Moines, as well as all books and records regarding the cemetery and remaining assets and authorized the execution of a Special Warranty Deed for the following property:

The North 24 1/2 Rods of the West 26 Rods of Lot 1 and all of Lot 2; and a part of Lot 1 described as follows:

Commencing at the NW corner of Section 36, Township 78 North, Range 24 West of the 5<sup>th</sup> P.M., thence on an assumed bearing of North 90° East, along the North line of Section 36, 429.0 feet to a point on the North section line of said Section 36, thence South 0° 13' East, 85.20 feet to the South easement line of Highway 5 and the point of beginning; thence continuing South 0° 13'East, 640.80 feet, thence North 90° East, 340.71 feet, thence North 0° 13' West, 638.42 feet to the South easement line of Highway 5, thence North 89° 36' West, 340.71 feet to the point of beginning;

all of the above being in the Official Plat of the NW 1/4 of the NW 1/4 of Section 36 Township 78 North, Range 24 West of the 5<sup>th</sup> P.M., Polk County, Iowa.

WHEREAS, the Park and Recreation Board at its October 23, 2007 meeting approved the acceptance of the Elm Grove Cemetery and responsibility for operation of such cemetery.
