## RESOLUTION RELEASING RESERVED UTILITY EASEMENT

WHEREAS, by Ordinance No. 11,264, the City of Des Moines vacated that part of the SW 6th Street right-of-way now within Lots 1, 2 and 3 of Riverpoint Plat No. 4, while reserving an easement for any utilities then in place; and,

WHEREAS, on February 6, 1989, by 89-492, the City Council approved the sale to F.M. Hubbell, Son & Company, Incorporated, of the vacated portion of SW 6th Street right-of-way now within Lots 1, 2 and 3 of Riverpoint Plat No. 4, while reserving an easement for any utilities then in place; and,

WHEREAS, Hubbell Realty Company, 501 SW 7th Street, LLC, and 535 SW 7th Street, LLC, represented by R. Michael Hayes, are now the owners of the said Lots 1, 2 and 3, and have requested that the City release the reserved utility easement; and,

WHEREAS, the City has received an Affidavit from Douglas Saltsgaver, a Licensed Professional Engineer with Engineering Resource Group, verifying that there are no functioning public utility services within the reserved utility easement; and,

WHEREAS, the City staff have confirmed that there are no City storm or sanitary sewers within the reserved utility easement; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council hereby finds that the easements for any public utilities then existing within the vacated SW 6th Street right-of-way reserved in Ordinance No. 11,264 passed February 6, 1989, and in the Corrective Special Warranty Deed to F.M. Hubbell, Son & Company, Incorporated, dated August 8, 1989, are no longer needed and may be released.
- 2. The accompanying *Release of Reserved Easement* prepared by the City Legal Department, which releases and discharges the reserved right-of-way easements is hereby approved.
- 3. The Mayor is hereby authorized and directed to sign the said *Release of Reserved Easement* on behalf of the City of Des Moines, and the City Clerk is hereby authorized and directed to attest to the Mayor's signature on such document.


