
SET HEARING FOR CORRECTED CONVEYANCE OF THE NORTH/SOUTH ALLEY BETWEEN 8TH STREET AND 9TH STREET, FROM CROCKER STREET TO CENTER STREET, AND A PORTION OF 9TH STREET RIGHT-OF-WAY BETWEEN CROCKER STREET AND CENTER STREET TO PRINCIPAL LIFE INSURANCE COMPANY

WHEREAS, on May 7, 2007, by Roll Call 07-890, after notice and public hearing, the City Council intended to approve the vacation and conveyance of the North/South alley between 8th Street and 9th Street, from Crocker Street to Center Street, and a portion of 9th Street right-of-way between Crocker Street and Center Street, but said Roll Call contained an error in the legal description due to a scrivener's error; and


