AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,250 passed July 14, 2003 and Ordinance 14,476 passed August 8, 2005, by amending Sections 114-3344 and 114-3689 thereof, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,250 passed July 14, 2003 and Ordinance No. 14,476 passed August 8, 2005, is hereby amended by amending Sections 114-3344 and 114-3689 relating to traffic and vehicle regulations, as follows:

Sec. 114-3344. Ingersoll Avenue--Twenty-eighth Street to Thirty-fifth Street.

Ingersoll Avenue, on the north side, from Twenty-eighth Street to a point 120 feet east of Twenty-ninth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the north side, from Twenty-ninth Street to a point 120 feet east thereof, no parking any time.

Ingersoll Avenue, on the north side, from a point 190 feet west of Twenty-ninth Street to a point ~~3050~~ 3050 feet west thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Ingersoll Avenue, on the north side, from Twenty-ninth Street to a point 40 feet west thereof, no parking any time.

Ingersoll Avenue, on the north side, from a point 40 feet west of Twenty-ninth Street to a point 100 feet west of Thirty-first Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the north side, from a point 100 feet west of Thirty-first Street to a point 90 feet west thereof, no parking any time.

Ingersoll Avenue, on the north side, from a point 190 feet west of Thirty-first Street to a point 150 feet east of Thirty-fifth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the south side, from a point 310 feet east of Thirty-first Street to a point 335 feet east of Thirty-first Street, no parking any time.

Ingersoll Avenue, on the north side, from a point 75 feet east of Crescent Drive to a point 35 feet west of Crescent Drive, no parking any time.

Ingersoll Avenue, on the north side, from Thirty-fifth Street to a point 150 feet east thereof, no parking any time.

Ingersoll Avenue, on the south side, from Twenty-eighth Street to a point 280 feet east of Twenty-ninth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the south side, from a point 180 feet east of Twenty-ninth Street to a point 100 feet east thereof, no parking any time.

Ingersoll Avenue, on the south side, from a point 180 feet east of Twenty-ninth Street to a point 30 feet east of Twenty-ninth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the south side, from a point 30 feet east of Twenty-ninth Street to a point 30 feet west of Twenty-ninth Street, no parking any time.

Ingersoll Avenue, on the south side, from a point 30 feet west of Twenty-ninth Street to a point 70 feet west of Crescent Drive, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the south side, from a point 70 feet west of Crescent Drive to 100 feet west thereof, no parking any time.

Ingersoll Avenue, on the south side, from a point 120 feet east of Twenty-ninth Street to a point 60 feet east thereof, no parking any time.

Ingersoll Avenue, on the north side, from a point 120 feet east of Thirty-fourth Street to a point 40 feet east thereof, no parking any time.

Ingersoll Avenue, on the south side, from a point 170 feet west of Crescent Drive to Thirty-fifth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Sec. 114-3689. University Avenue--Twenty-third Street to Twenty-fifth Street.

University Avenue, on ~~both sides~~ the north side, from Twenty-third Street to a point 75 feet west thereof, no parking any time.

~~University Avenue, on the south side, from a point 75 feet west of Twenty-third Street to Twenty-fifth Street, no parking 7:00 a.m. to 9:00 a.m.~~

University Avenue, on the south side, from Twenty-third Street to a point 95 feet west thereof, no parking any time.




