HEARING FOR VACATION AND CONVEYANCE OF THE EAST/WEST ALLEY BETWEEN INGERSOLL AVENUE AND HIGH STREET, FROM 17<sup>TH</sup> STREET TO A POINT APPROXIMATELY 175 FEET EAST OF 19<sup>TH</sup> STREET, TO 1717 INGERSOLL, LLC, PW WATERBURY LC, AND OPOMODO LLC FOR \$1 AND ALSO TO JAMES MARCOVIS FOR \$1

WHEREAS, on October 13, 2008, by Roll Call No. 08-1748, the City Council received a recommendation from the City Plan and Zoning Commission that a portion of the East/West alley between Ingersoll Avenue and High Street, from 17<sup>th</sup> Street to a point approximately 175 feet east of 19<sup>th</sup> Street, hereinafter more fully described, be vacated and sold; and

WHEREAS, the grantees identified below are the owners of property abutting such right-of-way and have offered to the City of Des Moines the purchase price identified below, and conveyance of required easements to the City, in exchange for the purchase of such property described below; and

WHEREAS, on October 27, 2008, by Roll Call No. 08-1844, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on November 10, 2008, at 5:00 p.m., in the Council Chamber; and

WHEREAS, on November 10, 2008, by Roll Call No. 08-2003, the City Council continued this hearing to November 24, 2008; and

WHEREAS, due notice of said proposal to vacate and convey said public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance of public right-of-way, as described below, are hereby overruled and the hearing is closed.
- 2. There is no public need for the right-of-way proposed to be vacated and the public would not be inconvenienced by reason of the vacation of the East/West alley between Ingersoll Avenue and High Street, from 17<sup>th</sup> Street to a point approximately 175 feet east of 19<sup>th</sup> Street, more specifically described as follows:

The Real Estate Division Manager is authorized and directed to forward the originals of the Quit Claim Deeds, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the originals of the Quit Claim Deeds and copies of the other documents to the grantees.
