APPROVAL OF AMENDMENT TO RECYCLABLES PROCESSING SERVICES CONTRACT WITH MID AMERICA RECYCLING, INC. FOR NEW PER TON RECYCLABLE MATERIAL PRICES PAYABLE TO THE CITY

WHEREAS, the Public Works Department provides a number of services including curbside collection for the processing of recyclables; and

WHEREAS, on November 18, 2002, by Roll Call No. 02-2710, the City Council accepted an RFP submitted by Mid America Recycling, Inc. for the processing of recyclables and authorized the City Manager to negotiate and execute a contract for such services; and

WHEREAS, the City entered into a contract with Mid America Recycling on December 17, 2002, resulting in the first time ever revenues for recyclables: and

WHEREAS, the contract provides that the parties will negotiate the per ton recyclable materials prices annually and new prices have now been negotiated for materials processed by Mid America Recycling, Inc.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Amendment to Contract By and Between the City of Des Moines, Iowa and Mid America Recycling, Inc. for Recyclables Processing Services for the Public Works Department, a copy of which is on file in the City Clerk's Office, is hereby approved and the City Manager is hereby authorized and directed to sign said Amendment on behalf of the City and the City Clerk is hereby authorized and directed to attest to his signature.

AMENDMENT

TO CONTRACT BY AND BETWEEN THE CITY OF DES MOINES, IOWA AND MID AMERICA RECYCLING, INC. FOR RECYCLABLES PROCESSING SERVICES FOR THE PUBLIC WORKS DEPARTMENT

THIS AMENDMENT is entered into this _____ day of _____, 2007, by and between the City of Des Moines ("the City") and Mid America Recycling, Inc. ("Mid America").

WHEREAS, on November 16, 2002, by Roll Call No. 02-2710, the City accepted Mid America's proposal for the processing of recyclables and authorized the City Manger to execute a contract for such recycling, which was executed by the City Manager on December 17, 2002 ("the Contract"): and

WHEREAS, Section 4 of the Contract provides that the parties may, at the City's discretion, negotiate the per ton price recyclable materials prices, excluding floor prices, annually; and

WHEREAS, the City and Mid America desire to amend the Contract to adjust the pricing structure.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the parties agree that the Contract shall be and is hereby amended as follows:

1. Section 4 is amended to revise the price per ton as follows:

The price for Newspaper will remain the "Yellow Sheet's" High Side of the Chicago Market for #8 Newspaper less \$26/ton.

The price for Mixed Paper will remain the "Yellow Sheet's" High Side of the Chicago Market for #1 Mixed Paper less \$26/ton.

Steel will increase from \$75/ton to \$95/ton.

The price of Clear Glass will increase from \$40/ton to \$45/ton.

The price of Office Paper will increase from \$85/ton to \$100/ton.

The price of OCC (Card Board) delivered will move to the "Yellow Sheets" High Side of the Chicago Market for OCC #11 less \$20/ton.

The floor prices for the following categories will be:

ONP	\$30/ton
Mixed paper	\$10/ton
Steel/Aluminum	\$20/ton
Plastic	\$55/ton
Glass	\$35/ton

- 2. The revised pricing will go into effect December 3, 2007.
- 3. Except as amended above, all other terms of the Contract shall remain in effect.
- 4. This Amendment shall be in full force and effect upon its execution by the parties.


