# APPROVAL OF CONTRACT AND BOND AND PERMISSION TO SUBLET ON AMERICAN DISCOVERY TRAIL WETLANDS MITIGATION \$ 126,370.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$126,370.00, executed by C.A.C., Inc., Chris Christensen, Owner, 3090 104th Street, Urbandale, IA, 50322 dated December 3, 2007, for the construction of the following improvement:

American Discovery Trail Wetlands Mitigation, 11-2008-002

US Army Corps of Engineers Permit No. CEMVR-P-2006-757

The improvement includes a twenty-one acre wetland construction project which includes earthwork, seeding, shrubs, trees and other related items, all in accordance with the contract documents including Plan File Nos. 478-077/088, in the vicinity of NE 118th Avenue and the Skunk River near Elkhart, Iowa in the northeast corner of Polk County



BE IT FURTHER RESOLVED: That the attached communication from said Contractor requesting permission to sublet designated items and the attached Permission to Sublet form, be and are hereby approved subject to each subcontractor's compliance with the City of Des Moines Contract Compliance Program. The City Manager is hereby directed to sign said Permission to Sublet form granting permission for said listed subcontractor to work on said improvement upon each subcontractor's compliance with the City of Des Moines Contract Compliance Program as monitored by the Engineering Department.
