WHEREAS, on June 4, 2007, by Roll Call No. 07-1076, the City Council approved the above-referenced COC application and authorized and directed the City Manager to submit the application to the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, on June 9, 2008 by Roll Call No. 08-1004, and on July 14, 2008 by Roll Call No.08-1215, in response to the above referenced COC application, the City Council approved 2007 Supportive Housing Program (SHP) Renewal Grant Agreements by and between HUD and the City of Des Moines, in the amount of \$287,355 for the Lighthouse Host Home Program, and \$289,732 for the House of Mercy Transitional Housing Program; and

WHEREAS, HUD has now forwarded Continuum of Care Grantee Closeout Certifications for the Lighthouse Host Home and House of Mercy Transitional Housing Programs on file with the City Clerk as Exhibits A and B, and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Mayor is hereby authorized and directed to sign the above-referenced Closeout Certifications and the City Clerk to attest to his signature.
