APPROVAL OF FISCAL YEAR 2003 CONTINUUM OF CARE (COC) CLOSEOUT  
CERTIFICATION DOCUMENTS

WHEREAS, in response to a Super NOFA published in the Federal Register on April 25, 2003, to supplement funding for local homeless programs, the City's Housing Services Department prepared an application for \$3,109,004 of Continuum of Care Program funds; and

WHEREAS, the application was developed from the City's Continuum of Care strategy, whereby COC funds would provide needed services to homeless persons in Des Moines and address high priority service gaps within the parameters of COC-eligible activities; and

WHEREAS, on June 23, 2003, by Roll Call No. 03-1464, the City Council approved the above-referenced COC application and authorized and directed the City Manager to submit the application to the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, on June 7, 2004, by Roll Call No. 04-1168, in response to the above referenced COC application, the City Council approved a 2003 Supportive Housing Program (SHP) Renewal Grant Agreement by and between HUD and the City of Des Moines, in the amount of \$298,174 for the Buchanan Transitional Living Center Project; and

WHEREAS, on June 7, 2004, by Roll Call No. 04-1167, in response to the above referenced COC application, the City Council approved a 2003 Supportive Housing Program (SHP) Grant Agreement by and between HUD and the City of Des Moines, in the amount of \$171,284 for the Iowa Homeless Management Information Network; and

WHEREAS, HUD has now forwarded Continuum of Care Grantee Closeout Certifications for the Buchanan Transitional Living Center Project and the Iowa Homeless Management Information Network, on file with the City Clerk as Exhibits A and B respectively, and by this reference made a part hereof.
