WHEREAS, on March 1, 2005, by Resolution No. A05-42, the Airport Board of the City of Des Moines recommended to City Council the authorization to proceed with the acquisition of the remaining properties by gift, sale, or eminent domain which are needed for the future Runway 13R/31L; and

WHEREAS, on March 7, 2005, by Roll Call No. 05-541, the City Council of the City of Des Moines, Iowa, approved the acquisition of properties by gift, sale, or eminent domain for the Airport Runway 13R/31L Project; and

WHEREAS, on August 7, 2007, by Resolution No. A07-137, the Airport Board of the City of Des Moines established fair market value and authorized acquisition of vacant property at the Northwest corner of SW 42nd Street and Army Post Road owned by Dodge Investment Co., Inc. of Des Moines in the amount of \$1,280,000 pursuant to the Runway 13R/31L; and

WHEREAS, on December 4, 2007, by Resolution No. A07-203, the Airport Board of the City of Des Moines recommended approval to City Council and authorization to make offer pursuant to a property acquisition settlement in the amount of \$1,395,000 for vacant property located at the northwest corner of SW 42nd Street and Army Post Road owned by Dodge Investment Company, Inc.; and
