WHEREAS, on May 23, 2005, by Roll Call No. 05-1277, the City Council approved the above-referenced COC application and authorized and directed the City Manager to submit the application to the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, on August 7, 2006, by Roll Call No. 06-1580, in response to the above referenced COC application, the City Council approved 2005 Supportive Housing Program (SHP) Renewal Grant Agreements by and between HUD and the City of Des Moines, in the amount of \$85,000 for the Primary Health Care Street Outreach Team Project and \$87,325 for the West Des Moines Transitional Housing Program; and

WHEREAS, on August 21, 2006, by Roll Call No. 06-1673, in response to the above referenced COC application, the City Council approved a 2005 Supportive Housing Program (SHP) Renewal Grant Agreement by and between HUD and the City of Des Moines, in the amount of \$256,109 for the Primary Health Care Enhancement Project; and

WHEREAS, HUD has now forwarded Continuum of Care Grantee Closeout Certifications for the Primary Health Care Enhancement Project, Primary Health Care Street Outreach Team Project and West Des Moines Transitional Housing Program, on file with the City Clerk as Exhibits A, B and C respectively and by this reference made a part hereof.
