RESOLUTION AFFIRMING THE DECISION OF THE CITY PLAN AND ZONING COMMISSION TO DENY APPROVAL OF A PLAT OF SURVEY FOR A SUBDIVISION IN THE VICINITY OF $3620 - 120^{\text{TH}}$ STREET

WHEREAS, by a decision entered July 31, 2007, the Permit and Development Administrator denied the application of Alycia Peterson for approval of a Plat of Survey for property in the vicinity of 3620 – 120th Street, for the reason that the Plat of Survey did not provide for the future extension of utilities or allow for a future street network through the subjection property; and,

WHEREAS, Alycia Peterson appealed the Administrator's decision to the City Plan and Zoning Commission, and at a public hearing held on September 28, 2007, the Commission voted to uphold the Administrator's decision; and,

WHEREAS, Alycia Peterson has appealed the Commission's decision to the City Council, and on December 3, 2007, by Roll Call No. 07-2301, it was duly resolved by the City Council that the appeal be set down for hearing on December 17, 2007, at 5:00 p.m., in the Council Chambers; and,

WHEREAS, due notice of the hearing was published in the Des Moines Register on December 7, 2007, was mailed to Alycia Peterson on December 11, 2007; and,

WHEREAS, in accordance with the said notice, those interested in the proposed Plat of Survey, both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council; and,

WHEREAS, Section 106-199(e) of the City Code provides that upon appeal from the Plan and Zoning Commission, a majority vote of the city council shall be necessary to overturn or modify the action of the commission regarding a Plat of Survey; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The public hearing on the appeal is hereby closed.
- 2. The City Council hereby approves and affirms the decision of the Plan and Zoning Commission to deny the proposed Plat of Survey of property in the vicinity of 3630 120th Avenue.

- 3. The City Council hereby makes the following findings in support of this decision:
 - a) The appellant has failed to demonstrate that the decision of the City Plan and Zoning Commission to affirm the denial of the Plat of Survey was unreasonable, arbitrary or capricious.
 - b) The proposed Plat of Survey does not provide for the future extension of utilities or for a future street network through the subject property to serve the subject property and adjoining properties.
 - c) The proposed Plat of Survey and the potential subdivision of similarly situated lands by plats of survey will operate to obstruct the orderly and efficient extension of streets, utilities and other public services and infrastructure necessary to serve the planned future development of the area.
