HOLD HEARING ON THE INTENT TO ACQUIRE PROPERTY FOR RECREATIONAL TRAIL PURPOSES AND AUTHORIZE ACQUISITION OF THE NECESSARY PROPERTY INTERESTS THEREOF FROM VARIOUS PROPERTY OWNERS FOR THE EAST INDIANOLA AVENUE WIDENING PROJECT BY GIFT, NEGOTIATION OR EMINENT DOMAIN

WHEREAS, under the provisions of 6B.2D of the lowa Code, a governmental body which proposes to acquire private property by eminent domain for recreational trail purposes is required to give notice of a proposed resolution, motion, or other document authorizing such acquisition of property to each property owner, contract purchaser of record and any tenant known to be occupying the property prior to the date of the meeting at which such proposed authorization will be considered; and

WHEREAS, on March 2, 2001, by Roll Call No. 01-643, the City Council approved the 2001-2002/2006-2007 Capital Improvements Program, including the proposed improvement to be known as the East Indianola Avenue Widening Project, which is further described as follows:

The phased construction of East Indianola Avenue Project, approximately 2.2 miles in length, would provide for reconstruction of the street to a 4-lane roadway between SE 14th Street and Army Post Road. The section north of Ewing Park would be either a 5-lane roadway, or a 4-lane roadway with left-turn lanes at major intersections. The section south of Ewing Park would be a 4-lane divided boulevard-type roadway. A separate multi-purpose trail may be included along the west side of the new roadway.

WHEREAS, on July 25, 2005, by Roll Call No. 05-1773, City Council approved the professional services agreement between the City of Des Moines and Snyder & Associates, Inc., for engineering services in conjunction with the East Indianola Avenue Corridor Study; and

WHEREAS, on October 8, 2007, by Roll Call No. 07-1994, City Council (1) approved the East Indianola Avenue Corridor Study, and (2) approved the professional services agreement with Snyder & Associates, Inc. (David Moeller, P.E., President, 501 SW Oralabor Road, Ankeny, Iowa 50021), for the East Indianola Avenue Roadway Design, total not to exceed \$988,908.00; and

WHEREAS, on November 19, 2007 by Roll Call No. 07-2200, City Council set the time and place for a hearing at which persons affected by the recreational trail portion of the East Indianola Avenue Widening Project may present their views regarding the proposed acquisition of private property for the recreational trail portion of the project by gift, negotiation or eminent domain; and


WHEREAS, authorized notice of this hearing was given as provided by law, setting forth the time and place for hearing on the proposal; and
