NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Preconstruction Agreement between the City of Des Moines and the Iowa Department of Transportation for the Ingersoll Run Phase 2 Storm Sewer Outlet Project, be and is hereby approved subject to approval by the Iowa Department of Transportation and the Mayor is authorized and directed to sign such Agreement and the City Clerk to attest to the Mayor's signature and return two original copies to the Engineering Department for transmittal to the Iowa Department of Transportation.


