APPROVAL OF RENEWAL AND AMENDMENT OF SEAT MANAGEMENT CONTRACT WITH PUBLIC TECHNOLOGY INSTITUTE AND L-3 COMMUNICATIONS GOVERNMENT SERVICES, INC.

WHEREAS, on July 8, 2002, by Roll Call No. 02-1707, the City Council approved the Seat Management Contract between and among the City of Des Moines, Public Technology, Inc. and EER Systems, Inc. to provide technology services (the "Contract"); and

WHEREAS, on September 27, 2004, pursuant to Roll Call 04-2057, the City Council approved and authorized the execution of an Addendum to the Contract changing EER Systems, Inc.'s name to L-3 Communications Government Services, Inc; and

WHEREAS, Article 5 of the Contract provides that the initial term of the Contract is 3 years and the Client has the option of extending the Contract on an annual basis for three additional 1 year periods; and

WHEREAS, on November 21, 2005, pursuant to Roll Call No. 05-2799, the City Council approved and authorized the execution of an Amendment To and Renewal of the Contract renewing the Contract for a one year term until July 17, 2006 and reflecting Public Technology, Inc.'s name change to Public Technology Institute; and

WHEREAS, it is in the best interest of the City to renew the Contract for an additional one year term, with the City having the option to terminate the Contract early upon 10 days notice, and to amend the Contact to allow the City to acquire IT hardware from alternative sources.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Renewal And Amendment Of Seat Management Contract Between And Among The City of Des Moines, Iowa, Public Technology Institute, Inc. and L-3 Communications Government Services, Inc., a copy of which is on file in the City Clerk's Office, for one year, is hereby approved and the Mayor is hereby authorized and directed to execute such Renewal and Amendment and the City Clerk is hereby authorized and directed to attest to his signature.
