APPROVING AMENDMENT TO SCHEMATIC PLAN FOR JOHN AND MARY PAPPAJOHN SCULPTURE PARK

WHEREAS, on March 24, 2008, by Roll Call No. 08-533, the City Council approved the John and Mary Pappajohn Sculpture Park Agreement with the Edmundson Art Foundation, Inc. ("Des Moines Art Center") for the development of the John and Mary Pappajohn Sculpture Park ("the Agreement"); and

WHEREAS, on March 24, 2008, by Roll Call No. 08-532, the City Council approved the Schematic Plan for the John and Mary Pappajohn Sculpture Park ("Sculpture Park"), which designates 17 sculptures and the location of each sculpture; and

WHEREAS, John and Mary Pappajohn desire to donate an additional 7 sculptures to the Des Moines Art Center and to replace one of the sculptures in the original Schematic Plan, which brings the sculpture collection to 24 pieces in total and requires some changes to the Schematic Plan; and

WHEREAS, section II.B of the Agreement establishes a Sculpture Committee, composed of John and Mary Pappajohn, or their designee, and one representative each from the Des Moines Art Center and the City; and

WHEREAS, the Sculpture Committee is charged with selecting sculptures for the Sculpture Park, approving the Supplemental Security Plan, and approving any amendment to the Schematic Plan; and

WHEREAS, the Sculpture Committee has approved the additional sculptures and the revised schematic Plan; and

WHEREAS, any material change to the Schematic Plan must also be approved by the City Council; and

WHEREAS, on November 25, 2008, by Board Action 08-10, the Park and Recreation Board approved the then current proposed amendment to the Schematic Plan, which at that time did not include the Butterfield sculpture.
