That the Finance Director be and is hereby authorized to draw the checks listed on the check registers for the weeks of December 22 and December 29; to draw the checks for the bills of the Des Moines Municipal Housing Agency to be presented to the Finance Director for the week of December 22; and to draw the checks for biweekly payroll due employees of the City on January 2nd, 2009.

BE IT FURTHER RESOLVED, that the Treasurer be and is hereby authorized and directed to make the necessary disbursements and the necessary cash transfers to the revolving funds.
