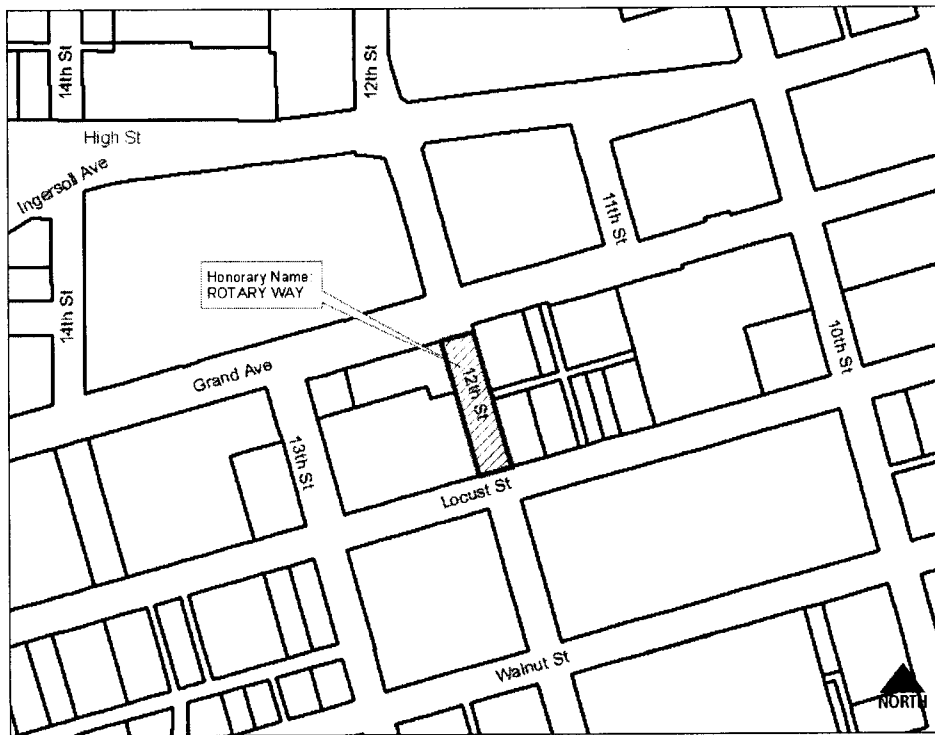

STAFF REPORT

I. GENERAL INFORMATION

1. **Purpose of Request:** The City Council is considering a request to honorarily name a segment of 12th Street near the Des Moines Central Public Library to "Rotary Way".

The Rotary Club of Des Moines intends to rename the street the first week in May of 2011 to commemorate "The Rotary Club of Des Moines Centennial Week".

There is no formal review process for the honorary naming of streets as there is for the official renaming of streets. This proposal is being forwarded to the Plan and Zoning Commission for courtesy review and comment.

2. **Size of Site:** One-block segment of 12th Street.

3. **Adjacent Land Use and Zoning:**

West – "C-3A", Uses are the Pappajohn Higher Education Center and Western Gateway Park.

East – "C-3A", Use is the Des Moines Central Public Library.

4. **Applicable Recognized Neighborhood(s):** Downtown Des Moines Neighborhood.

II. ADDITIONAL APPLICABLE INFORMATION

1. **Street System:** The honorary naming of 12th Street will have no impact on traffic or postal delivery to adjoining properties.
