**APPROVING AND AUTHORIZING THE PROCUREMENT OF A REPLACEMENT PUMP AND RELATED EQUIPMENT FOR THE SE AIRPORT SANITARY LIFT STATION FROM ELECTRIC PUMP & TOOL SERVICES INC.**

WHEREAS, the Public Works Department Sewer Enterprise Division requested the Procurement Division to procure a replacement pump and related equipment for the Se Airport Sanitary Lift Station in the amount of \$37,300.20; and

WHEREAS, on December 18, 2000, by Roll Call # 00-4569, the Des Moines City Council approved and authorized the execution of a contract with Electric Pump & Tool Services, Inc., 4280 NE 14<sup>th</sup> Street, Des Moines, IA 50313, Richard Miller, President, for the provision of new pumps for new pump stations, for the provision of replacement pumps for existing pump stations, for the provision of pump repair parts and management of the City's pump repair parts inventory, and for the provision of pump repair services; and

WHEREAS, on December 5, 2005, by Roll Call # 05-2900, the Des Moines City Council approved and authorized the execution of addendum and amendment to said contract with Electric Pump & Tool Services, Inc. wherein the Des Moines Metropolitan Wastewater Reclamation Authority (WRA) was added as a party to the contract, the contract was renewed for a 3-year term, and the Master Price Listing was replaced; and

WHEREAS, on December 8, 2008, by Roll Call # 08-2138, the Des Moines City Council approved and authorized the execution of an addendum to said contract with Electric Pump & Tool Services Inc., wherein the contract was renewed for another 3-year term, and the Master Price Listing was replaced; and

Whereas funding is available from PWK074001/Sanitary Sewer Pump Station;

NOW, THEREFORE, BE IT RESOLVED, that the procurement of a replacement pump and related equipment for the SE Airport Sanitary Lift Station from Electric Pump & Tool Services Inc. in the amount of \$37,300.20 is hereby approved and the Procurement Administrator is hereby authorized and directed to issue a purchase order for same.
