## RESOLUTION APPROVING AN AMENDED CONCEPTUAL DEVELOPMENT PLAN AND A FIRST AMENDMENT TO THE URBAN RENEWAL DEVELOPMENT AGREEMENT WITH BROWNSTONES ON GRAND, LLC, REGARDING THE BROWNSTONES ON GRAND

WHEREAS, Brownstones on Grand, LLC, (the "Developer"), being a subsidiary of Hubbell Realty Company represented by Steven L. Niebuhr, Senior Vice President, is the owner of the Property at 201 Grand Avenue more specifically described as follows:

Lots 1-25, Brownstones on Grand Plat 2, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa (a replat of Lots 19-43, Brownstones on Grand).

WHEREAS, the Property is located in the Metro Center Urban Renewal Area in a part of the downtown characterized by underutilized and vacant land and a pattern of disinvestment and declining resident population and employment; and,

WHEREAS, by the City Council has previously identified the need for additional housing in the downtown area to support continued growth and of the downtown as a commercial and employment center, and has identified the Property as an appropriate location for the development of such housing; and,

WHEREAS, the City and Developer had previously entered into an Urban Renewal Development Agreement, dated January 7, 2008 (the "Development Agreement"), regarding development of 25 additional residential units on the Property; and,

WHEREAS, instead of developing these 25 town homes in three buildings as originally proposed, Developer desires to develop these 25 town homes in four (4) 4-plex units on the north side of the project, and in one 5-plex unit and one 4-plex unit along the east side of the project; and

WHEREAS, the Developer has requested that the Development Agreement be amended to conform to the revised plans for development of the Property; and,

WHEREAS, the City Manager has negotiated a First Amendment to Urban Renewal Development Agreement which is on file and available for public inspection in the office of the City Clerk; and,

WHEREAS, the Urban Design Review Board considered the proposed amended Conceptual Development Plan for the 25 additional townhomes to be constructed on the Property
