ACCEPTANCE OF REAL ESTATE FROM RYAN GALLOWAY FOR \$1 AND DEDICATION OF SAID PROPERTY AS RIGHT-OF-WAY

WHEREAS, on May 18, 2009 and October 25, 2010, by Roll Call Nos. 09-902 and 10-______, the City Council of the City of Des Moines approved the vacation and conveyance of portions of excess street and alley rights-of-way located between 18th Street and 19th Street from Atkins Street to Day Street to Ryan Galloway, owner of 1051 19th Street, for assemblage for site plan of multiple-family residential redevelopment; and

WHEREAS, on September 16, 2010 the City Plan and Zoning Commission received a request from Hatch Development Group (developer), represented by Jack Hatch, for review and approval of a Site Plan "MLK Brickstone Apartments Phase 2" under design guidelines in NPC Districts and for Multiple-family Residential, on property located at 1051 19th Street, to allow construction of a three-story residential apartment building with 30 units, and thereafter the City Plan and Zoning Commission recommended approval of the submitted site plan under the "NPC" District Design Guidelines and design guidelines for multiple-family dwellings subject to various conditions; and

WHEREAS, upon further review of Phase 2 of the MLK Brickstone Apartments project, it was determined by Plan and Zoning Staff that a portion of the City property previously conveyed for Phase 1 of said project is not necessary for the redevelopment project and should be transferred back to the City and re-dedicated by the City as public right-of-way, which property is legally described as follows:

The west ½ of the vacated north/south alley right-of-way lying east of and adjoining the north 10.0 feet of the south 20.0 feet of Lot 42, Butler's Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa; and
