WHEREAS, pursuant to Section 126-185 on September 13, 2010, by Roll Call No. 10-1463, the City Council opened the public hearing on the matter of the application at its regular meeting on September 27, 2010 and by Roll Call No. 10-1588 of September 27, 2010, the City Council continued the public hearing to October 11, 2010 and by Roll Call No. 10-1679 of October 11, 2010, the City Council further continued the public hearing to this date; and

WHEREAS, Section 126-186 provides if this Council finds at the conclusion of such public hearing that further taxicab service in the City of Des Moines is required by the public convenience and necessity and the applicant is fit, willing, and able to perform such public transportation and to conform to the provisions of the subchapter, then the Council shall direct the City Traffic Engineer to issue a certificate stating the name and address of the applicant, the number of vehicles authorized under said certificate and the date of issuance; otherwise the section provides the application shall be denied; and

WHEREAS, this Council shall take into consideration the information in the application and the factors set forth in Section 126-186(a), including the character, experience, and responsibility of the applicant.

Dear Mr. Fox:

The following information is provided in response to your correspondence dated October 13, 2010:

- 1. Attached as Appendix "A" is the Balance Sheet of assets and liabilities of United Cab Ltd. Mr. Mohamed Habib has been saving money since he first came to the United States with the goal of establishing his own business. United Cab Ltd. was formed on April 28, 2010. The corporation has approximately \$10,350.00 in cash and owns the vehicles without any liens or encumbrances. There are no unpaid judgments for United Cab Ltd. or its owner, Mohamed Habib.
- 2. Mohamed Habib is the sole principal of United Cab Ltd. He came to the United States in 1997. From 1994 to 1997 he worked as a taxicab driver in his native country of Kenya. He became a supervisor and would come to work at 6:00 a.m. to check the vehicles and make sure the drivers reported to work before he left with his taxicab. He returned to the cab company approximately 30 minutes early in the afternoon to check the vehicles in and collect the trip reports. One of his first jobs after coming to the United States was a dishwasher and kitchen worker in the hotel industry. After a series of promotions he served as an assistant banquet manager for 5 years which provided valuable experience in supervising others. From February, 2010 to early October he has served as a taxicab driver for Freedom Cab. He was grateful that a representative of Freedom Cab told the City Council that he had done good work for their company.

3. The principal place of business for United Cab Ltd. is 2500 MLK, Suite 4, Des Moines, Iowa. The building includes an underground garage/storage area that can accommodate vehicles that are not in use. Mr. Habib currently has two vehicles that can be used in a back up capacity. The equipment will initially be serviced and maintained at the facilities of All Pro Servicenter located 5904 Meredith Drive in Urbandale. If the City issues United Cab Ltd. a Certificate, Mr. Habib plans to transition the service and maintenance work to the underground garage/storage area. Attached as Appendix "B" and "C" is an updated list of vehicles and drivers.

All taxicabs will be dispatched from the principal place of business on a 24 hour basis. There will be two 12 hour driver shifts beginning at 6:00 a.m. and 6:00 p.m. daily. In addition to Mohamed Habib, there will be a full time dispatcher and several part time dispatchers. A standard dispatcher shift will be 12 hours with alternative scheduling on a 8 hour basis. Attached as Appendix "D" are the documents to be used in providing service including the Dispatch Register, Driver Daily Record and Receipt. The drivers will be supervised by Mohamed Habib who has worked with them in understanding the importance of neatness in their appearance and full compliance with the City's regulations. The Dispatch Register will allow Mohamed Habib to monitor the timeliness of service. In addition, a Service Plan has been developed with Sprint to assign cell phones to the 5 taxicabs with GPS capability so the location of each taxicab can be tracked by dispatch.

4. On advice of Counsel, Mohamed Habib delayed filing his application to provide service to surrounding communities until after the initial hearing with the City Council. The application filed with the City was the core of his plans to provide service. "Deadheading" after bringing a passenger into Des Moines and having to turn away intra-city service was inconsistent with the efficient use of his equipment and the timely service he planned to provide. After losing his job in early October he applied to the Iowa DOT and secured the required authority. Attached as Appendix "E" are the documents showing the service he provided in October.

It is apparent that the City Council is giving our application serious consideration. United Cab Ltd. appreciates their consideration and the efforts of your staff in assisting us with the application process.



Attached is a copy of the 2009 Assessment Roll confirming that the property is zoned as commercial and thus appropriate for the business proposed by applicant. The equipment will be serviced and maintained at the facilities of All Pro Servicenter located at 5904 Meredith Drive in Urbandale, Iowa. Attached is a report from the Polk County Assessor confirming that the property is zoned commercial. When not in use, the vehicles will be parked at the home of the assigned driver or in the rear of the home where Mohamed Habib resides located at 1130 31st Street in Des Moines. Attached is a report from the Polk County Assessor confirming that the property is zoned residential.
- 5. Applicant will have a telephone listing with Yellow Book which uses the listed telephone number of 515-277-7784. Attached is the E-mail confirming the arrangements for a 1 inch by a 2 inch listing in the Yellow pages.

- Mohamed Habib, the sole owner of applicant moved to Des Moines in 1997. He 9. had been a taxicab driver in his native Country of Kenya for four (4) years. He has been driving a cab in Des Moines for the last six (6) months and is familiar with the procedures and requirements for providing the service. His license privileges have never been suspended or revoked. He has never been denied a license or the renewal of a license.
- Mohamed Habib has never been convicted of, pled guilty to, or stipulated to the 10. facts of a violation of a criminal statute or ordinance. The Certified Abstract of Driving Record indicates that he has had one speeding violation with a conviction date of May 3, 2006.

- VI.
