APPROVING AGREEMENTS TO ASSIST HOMEOWNERS AFFECTED BY  
THE 2010 FLOODING IN POLK COUNTY THROUGH THE  
IOWANS HELPING IOWANS UNMET NEEDS DISASTER ASSISTANCE PROGRAM

WHEREAS, Des Moines Community Action Agency is charged with providing services to the City's low-income families through the Community Services Block Grant (CSBG) funding to assist low-income families and individuals with basic energy, food, shelter needs and working towards achieving self-sufficiency.

WHEREAS, the State of Iowa Department of Human Services (IDHS) has developed the Iowans Helping Iowans Unmet Needs Disaster Assistance Program to assist with disaster victims; and

WHEREAS, the IDHS desires to enter into An agreement with the City of Des Moines denominated the Contract Declarations & Execution Contract to administer the Iowans Helping Iowans program for eligible residents in Polk County; and

WHEREAS, granted funds would be disbursed to the City of Des Moines with which to provide funding to Des Moines residents per the disaster-related hardship criteria; and

WHEREAS, the City acting as the fiscal agency is authorized to enter into a sub-agreement with the Red Rock Community Action Program to provide services to non-Des Moines, Polk County residents; and

WHEREAS, an Agreement between the City of Des Moines and the Red Rock Community Action Program, which is on file in the City Clerk's office, has been created to meet this service need area.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above-referenced Contract Declarations & Execution Contract on file in the City Clerk's Office is hereby approved and that the Mayor is hereby authorized and directed to execute the same.

NOW THEREFORE, BE IT ALSO RESOLVED by the City Council of the City of Des Moines, Iowa, that the above-referenced Sub-Agreement with Red Rock Community Action Program is hereby approved and the Mayor is hereby authorized and directed to execute the same.
