**APPROVING MAJOR AMENDMENT #4 TO THE COMMUNITY DEVELOPMENT BLOCK GRANT HOUSING DISASTER RECOVERY (CDBG-DR) FUND CONTRACT WITH IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT—IDED (CONTRACT NUMBER 08-DHR-209).**

WHEREAS, the Iowa Department of Economic Development (IDED) administers Community Development Block Grant (CDBG) Disaster Recovery Funds to assist with flood recovery per a statewide allocation plan approved by the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, IDED and the City of Des Moines previously entered into a Contract (the "Contract") pursuant to which IDED granted funds to the City of Des Moines to aid in recovery from the natural disasters of 2008; and

WHEREAS, on June 28, 2010 the City of Des Moines by Roll Call Nos. 1095 and 1096 submitted two funding applications to IDED for the development of multi-family rental housing; and

WHEREAS, IDED has approved funding for the Anawim/Hubbell project in the 2200 block of Forest Avenue and The Younkers Building/Alexander Company project; and

WHEREAS, Major Amendment #4 (attached as Exhibit A) adds funds for the above mentioned projects into an existing contract held between the City of Des Moines and IDED; and


WHEREAS, Major Amendment #4 extends the Contract End Date to March 31, 2012
