ACCEPTING AND APPROVING SUB-GRANTEE AGREEMENT TO ADMINISTER
FY 2010 HOMELAND SECURITY GRANT PROGRAM FUNDS FROM
IOWA'S HOMELAND SECURITY AND EMERGENCY MANAGEMENT DIVISION

WHEREAS, Iowa Homeland Security and Emergency Management's Director requested the City of Des Moines serve as the fiscal agent and authorized representative for the administration of Iowa's FY 2010 Homeland Security Grant Program (Cyber Risk Reduction) funds on behalf of the State of Iowa Information Security Office; and

WHEREAS, the U.S. Department of Homeland Security (DHS), allocated funds to states and local governments through the federal Homeland Security Grant Program for approved initiatives supporting national priorities and state strategies directed toward prevention, response, mitigation and recovery efforts related to terrorist attacks; and

WHEREAS, the DHS has awarded the State of Iowa State a Cyber Risk Reduction grant in the amount of \$312,378 and the State has prepared a sub-grantee agreements (Sub-Grant #2010-SS-TO-0031-20), on file in the Office of the City Clerk, for execution by the City of des Moines..

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City of Des Moines to serve as the Sub-grantee and Fiscal Agent for the Management and Administration of Iowa's Homeland Security Cyber Risk Reduction Grant Program (Sub-Grant #2010-SS-TO-0031-20).

BE IT FURTHER RESOLVED that the above described Agreement for Sub-Grant #2010-SS-TO-0031-20 with the Iowa Homeland Security and Emergency Management Division is hereby approved and the Mayor is authorized to sign said Agreement on behalf of the City, and the City's Finance Department and Information Technology Department are directed and authorized to work with the Iowa Homeland Security and Emergency Management Division staff to implement said grant and to perform any necessary action in compliance with said grant.
