## ORDERING CONSTRUCTION OF MULBERRY STREET PAVING - 13TH STREET TO 15TH STREET AND FIXING A DATE FOR RECEIVING OF BIDS ON MARCH 1, 2011 AND PUBLIC HEARING ON MARCH 14, 2011 ENGINEER'S ESTIMATE IS \$3,430,000.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Jurisdictional Engineer, submitting plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of cost for the construction of the following improvement:

Mulberry Street Paving - 13th Street to 15th Street, 06-2010-017

The improvement includes clearing and grubbing, rubble and structure removal, pavement removal, excavation of approximately 25,000 cy, and importation of approximately 60,500 cy of fill material, storm and sanitary sewer, water main, subdrains, modified base, PCC pavement driveways and sidewalks, composite patches, modular block wall, fence, traffic signals, pavement markings, erosion control, landscaping and site restoration; all in accordance with the contract documents including Plan File Nos. 528-001/182 at Mulberry Street from 13th Street to 15th Street, Des Moines, Iowa

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$3,430,000.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Jurisdictional Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on March 14, 2011, at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the City Clerk until 11:00 a.m. on March 1, 2011, for the construction of said improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Jurisdictional Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on March 1, 2011, after which the bids together with a bid tabulation and recommendation of the Jurisdictional Engineer will be presented to the City Council at its next meeting for action thereon.


