APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR SANITARY SEWER IMPROVEMENTS, SOUTHERN RIDGE, BETWEEN MCANINCH CORPORATION AND WEST LAKES PROPERTIES, LLC

WHEREAS, on May 9, 2005 under Roll Call No. 05-1120, the City Council approved a private construction contract in the amount of \$288,200.00, between McAninch Corporation, Douglas D. McAninch, President, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and West Lakes Properties, LLC, Gerard D. Neugent, Manager, 4949 Westown Parkway, Suite 200, West Des Moines, IA, 50266 - as Owner, for construction of Sanitary Sewer Improvements described as Southern Ridge Sanitary Trunk Sewer to serve a future Knapp Properties development, located east of SW 9th Street between Highway 5 and County Line Road, as per Plan File Nos. 445-109/114, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


