WHEREAS, Cameron Sadeghpour is the owner of 1931 Leyner Street, which property abuts the south portion of the above-described alley, and has offered to the City of Des Moines the purchase price of \$50.00 for the purchase of such property for expansion and incorporation with his current residential property, which purchase price reflects the fair market value of the property as currently estimated by the City's Real Estate Division and in accordance with City policy.


