WHEREAS, on January 24, 2011 by Roll Call 11-0106, City Council approved Forms of Agreement among West Bank, the Federal Home Loan Bank, and the City of Des Moines for implementation of the Grants; and

WHEREAS, West Bank has requested that the City of Des Moines approve an additional agreement that provides processes and procedures for satisfying monitoring and compliance requirements; and

WHEREAS, an agreement has been developed setting the terms and conditions for the use of these funds and is on file with the City Clerk as Attachment 1.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that

- 1. The Community Development Department's Neighborhood Conservation Services Division will work in cooperation with West Bank to disperse the Affordable Housing Program Grant funds.
- 2. The form of agreement on file with the City Clerk as Attachment 1 is hereby approved and the City Legal Department is hereby authorized to approve any non-substantive changes necessary to finalize the document.
