RESOLUTION APPROVING SUPPORT FOR AN APPLICATION TO THE IOWA HOUSING FINANCE AUTHORITY SUBMITTED BY JACK HATCH ON BEHALF OF GREYSTONE HOMES L.P. REQUESTING LOW INCOME HOUSING TAX CREDITS FOR CONSTRUCTION OF 26 UNITS OF SINGLE FAMILY HOUSING AT SCATTERED SITES

WHEREAS, the City of Des Moines, Iowa, has been informed by Jack Hatch and Ryan Galloway, Hatch Development Group, 1312 Locust Street, 50309 that a Low Income Housing Tax Credit (LIHTC) application will be filed by Greystone Homes, LP, with the Iowa Finance Authority for the construction of 26 units of single family housing located at various locations in the City of Des Moines, Polk County, Iowa, described as follows:

WHEREAS, the proposal is in conformance with the criteria for Council review and support of LIHTC applications adopted on December 8, 2008, by Roll Call No. 08-2162 because the development will build a significant number of housing units on infill sites located near the 19th and Martin Luther King Jr. Corridors and will add three bedroom units for families, which is a need identified in the City's Consolidated Plan; and,

WHEREAS, the proposal is not in conformance with the City's Affordable Housing Policy for Low Income Housing Tax Credit Projects in low density areas adopted by Roll Call 03-3654 on November 21, 2003 because the development adds 11 assisted units to the block face with 38 lots, which exceeds the threshold of 20% of all units on the immediate block face or in the immediate area as described in the policy, and all the housing is to be built within low income census tracts; and,

WHEREAS, the City's Affordable Housing Policy for Low Income Housing Tax Credit Projects further provides that the 20% threshold on low income units on the immediate block face or in the immediate area can be adjusted if extra design criteria has been added which is the case with the Greystone houses; and

WHEREAS, the developer has received support from the three Neighborhood Associations in the vicinity of the project, and has offered to work closely with the King Irving Neighborhood on their concerns; and

WHEREAS, the 26 homes have an affordability period of 15 years and will then convert to affordable Home Ownership; and

WHEREAS, the developer has requested Enterprise Zone Credits, 10- year tax abatement and possibly City/State HOME funds.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Council supports the project for the purpose of receiving Low Income Housing Tax Credits from IFA subject to compliance with all City ordinances, which includes the Zoning and Site Plan Ordinances, and the building permit process. This resolution is

effective until December 31, 2011. In the event that any of the characteristics mentioned above should change prior to the issuance of a building permit, this resolution is null and void.

BE IT FURTHER RESOLVED, by the City Council of the City of Des Moines, Iowa, that the City Manager, or his designee is hereby authorized and directed to complete and sign the attached Local Contributing Effort Form that shows Enterprise Zone Credits, ten year tax abatement, and authorizes staff to negotiate with IFA and the developer on HOME funds.
