WHEREAS, pursuant to Section 126-155 on September 27, 2010, by Roll Call No. 10-1586, the City Council of the City of Des Moines approved an application by Joy Ride Transportation LLC for a license to operate a paratransit taxicab service, with a total of three vehicles; and

WHEREAS, Joy Ride Transport LLC, 1580 SE Bristol Drive, Waukee, Iowa, has filed an application requesting permission of the City Council to increase the size of their paratransit taxicab service fleet from a total of three vehicles to a total of six vehicles; and

WHEREAS, Staff has reviewed the application and the liability insurance certificate and has determined that Joy Ride Transport LLC continues to meet the requirements for providing paratransit taxicab service.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

That the hearing is hereby closed and the application is granted or denied, as the case may be, as set out in the next paragraph.
