WHEREAS, the City of Des Moines has no current or anticipated public need for the Property and the City will not be inconvenienced by the sale of said Property; and

WHEREAS, on February 28, 2011, by Roll Call No. 11-0306, it was duly resolved by the City Council that the proposed conveyance of said Property to Des Moines Regional Transit Authority (DART), for \$40,240.00 be set down for hearing on March 14, 2011, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to convey public property was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

- 2. The conveyance of the following described property to Des Moines Regional Transit Authority (DART), for \$40,240.00, be and is hereby approved:


