AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by repealing subsection (a) of Section 102-319 thereof, and enacting a new subsection (a) of Section 102-319 thereto, regarding the boundaries of the Skywalk District, and by replacing the Skywalk System Plan Map adopted by reference in paragraph (b) of said Section 102-319, with the Skywalk System Plan Map dated March 28, 2011.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. The Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827 passed June 5, 2000; as amended by Ordinance No. 13,970 passed July 23, 2001; by Ordinance No. 14,564, passed May 8, 2006; and by Ordinance No. 14,565 passed May 8, 2006; be and is hereby amended by repealing subsection (a) of Section 102-319 thereof, and enacting a new subsection (a) of Section 102-319 thereto, regarding the boundaries of the Skywalk District as follows:

Sec. 102-319. Skywalk district and skywalk map.

(a) The skywalk district is the area enclosed by the following described boundary:

The west bank of the Des Moines River from the north line of Grand Avenue to the south line of Court Avenue; the south line of Court Avenue from the west bank of the Des Moines River to the west line of Fifth Avenue; the west line of Fifth Avenue from the south line of Court Avenue to the north line of Cherry Street; the north line of Cherry Street from the west line of Fifth Avenue to the west line of Thirteenth Street; the west line of Thirteenth Street from the north line of Cherry Street to the north line of Walnut Street; the north line of Walnut Street from the west line of Thirteenth Street to the west line of Sixteenth Street; the west line of Sixteenth Street from the north line of Walnut Street to the south line of Locust Street; the south line of Locust Street from the west line of Sixteenth Street to the east line of Eleventh Street; the east line of Eleventh Street from the south line of Locust Street to the north line of Grand Avenue: the north line of Grand Avenue from the east line of 11th Street to the east line of 12th Street; the east line of 12th Street from the north line of Grand Avenue to the south line of relocated High Street: the south line of relocated High Street from the east line of 12th Street to the west line of 10th Street; of High Street; the north line of High Street from the east line of Eleventh Street to the west line of Tenth Street; the west line of Tenth Street from the north south line of High Street to the south line of Pleasant Street; the south line of Pleasant Street from the west line of Tenth Street to an extension of the west line of lot 12 Methodist Plat No. 1; the extension of the west line of lot 12 Methodist Plat No. 1 from the south line of Pleasant Street to the south line of Chestnut Street; the south line of Chestnut Street from the west line of lot 12 Methodist Plat No. 1 to the west line of Ninth Street; the west line of Ninth Street from the south line of Chestnut Street to the north line of Center Street; the north line of Center Street from the west line of Ninth Street to the west line of Fifth Street; the west line of Fifth Street from the north line of Center Street to the north line of Crocker Street; the north line of Crocker Street from the west line of Fifth Street to the east line of Third Street; the east line of Third Street from the north line of Crocker Street to the north line of Watson Powell, Jr. Way; the north line of Watson Powell, Jr. Way from the east line of Third Street to the east line of Second Avenue; the east line of Grand Avenue from the north line of Grand Avenue from the east line of Second Avenue from the east line of Second Avenue from the Des Moines River.

Sec. 2. That the Skywalk System Plan Map of the City of Des Moines, Iowa, adopted by reference in paragraph (b) of Section 102-319 of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by replacing the adopted Skywalk System Plan Map with the Skywalk System Plan Map dated March 28, 2011, which shall be on file and available for public inspection in the office of the City Clerk.

Sec. 3. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

The table to the right provides dentification as provided with the initial skywalk agreements and ordinances, a reference guide showing theprevious number and the current identifier label The alpha-numerical system will supercede any previous numerical or the various skywalk bridges.

- alpha-numerical identification based on a future potential southern District boundary of Vine Street and the Des Moines River as the east boundary. 1) Each block in the Skywalk System District has been assigned an
- a) South to North alpha-identification begins with A at Vine Street, B - at Cherry Street, C - at Court Avenue/Mulberry Street, and so on.
- b) East to West numerical-identification begins with 1 at 1st Street,
 - 2 at 2nd Avenue, 3 at 3rd Street and so on.
- the numeric system previously used (i.e. 7B 7C replaces bridge number 1 2.) The bridge numbers are based on block reference numbers with the bridge spans from one block to another using an alpha-number. This sytem replaces
- a) Where more than one bridge can be assigned an identical reference label, it will be differentiated by N, S, E, W, in conjunction with their physical location on the block (i.e. 7BE - 7CE and 7BW - 7CW).
- b) When a bridge spans an alley, it will be labeled with the block reference number followed by a lower case "a". Where there is more than one alley bridge in a block, it will be differentiated by N, S, E or W in conjunction with the physical location on the block. (i.e. 7Ba for a single alley, 7CaE and 7CaW for multiple).
